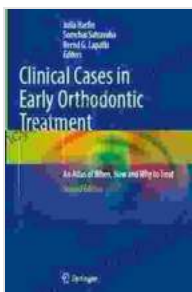

### Interceptive Orthodontics


The aim of this early orthodontic treatment is to :

- 01 Correct facial asymmetry by directing jaw growth.
- 02 Shifting protruding teeth into place to minimize the risk of trauma.
- 03 Making space for the grown up teeth to come in straight.
- 04 Helping with crowding to prevent permanent teeth from getting impacted or erupting at the wrong angles.
- 05 Correcting problems with chewing and speaking.
- 06 Boosting the Child's confidence and self-esteem.

This is done when the child is still growing, and have most of their primary teeth.


#### Phase 1 Orthodontic treatment

This phase involves a child wearing an appliance like a **Space maintainer, Palatal expander or Limited braces**, which aims to bring the teeth and jaws in normal growth pattern.



#### Phase 2 Orthodontic treatment

Phase-2 begins around the age of 12 or 13, which may consist of **Fixed braces, Removable appliance or Invis align (Clear aligners)** This will help to correct the bite and give them a beautiful, healthy smile.

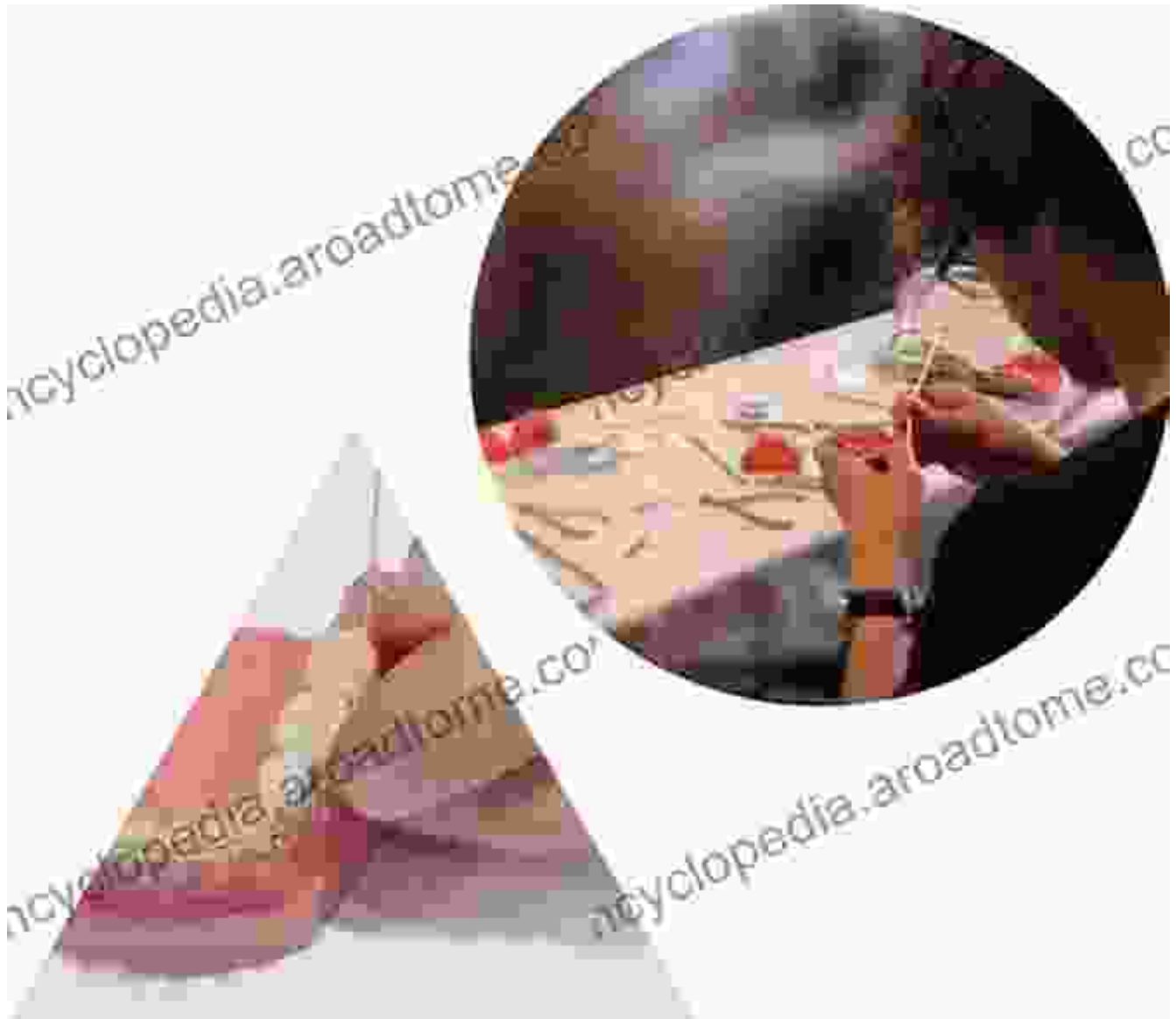

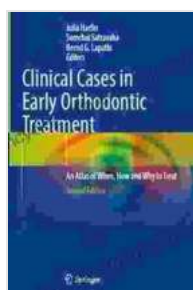
